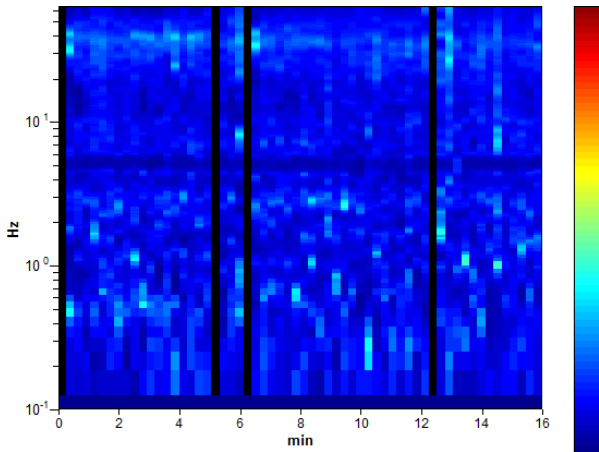

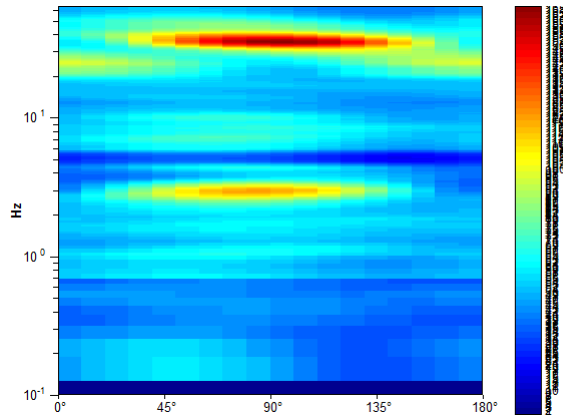

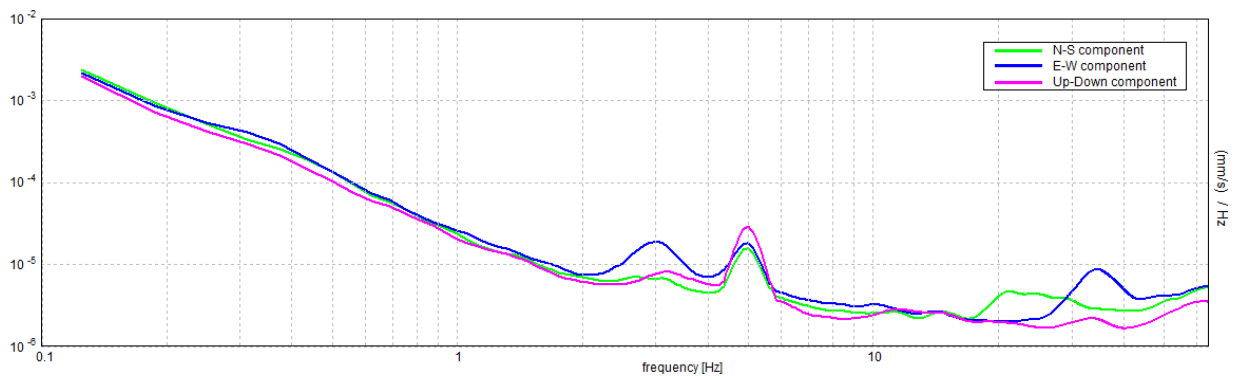
H/V TIME HISTORY

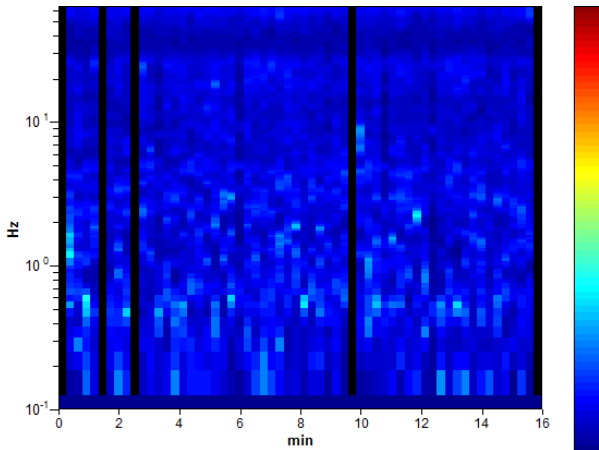

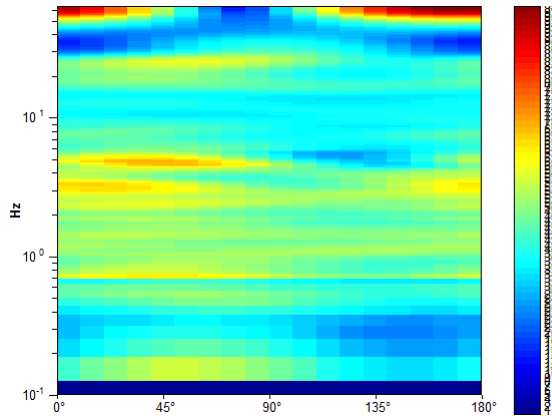

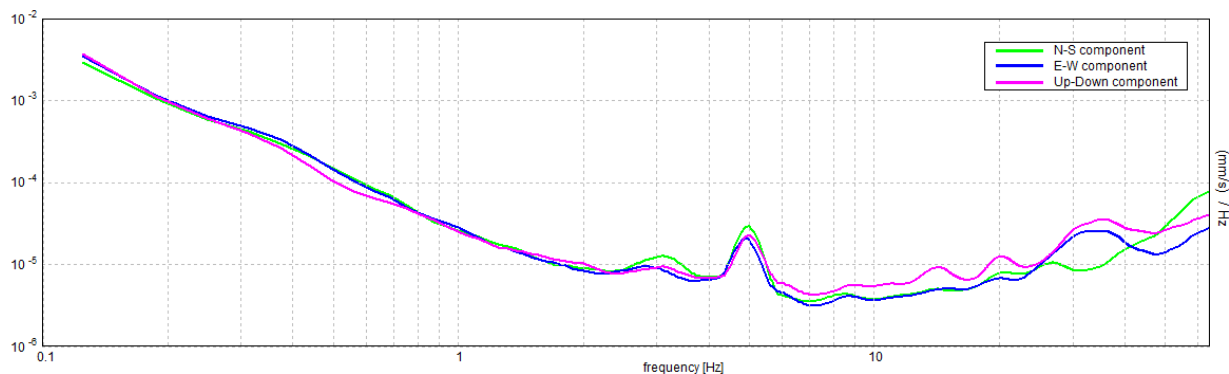
H/V TIME HISTORY

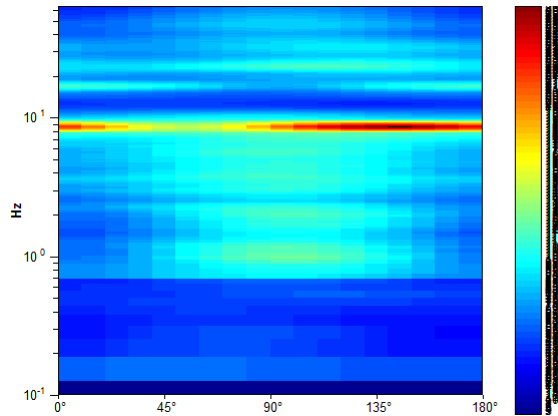

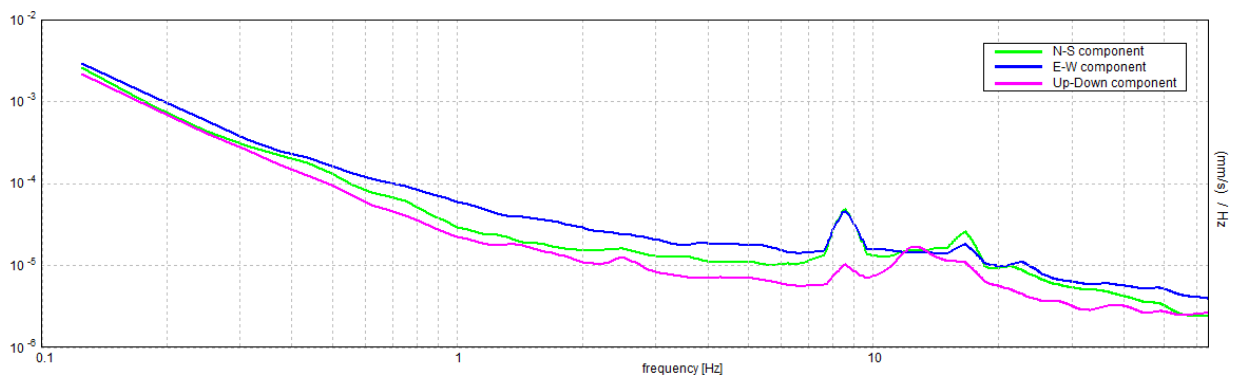
H/V TIME HISTORY

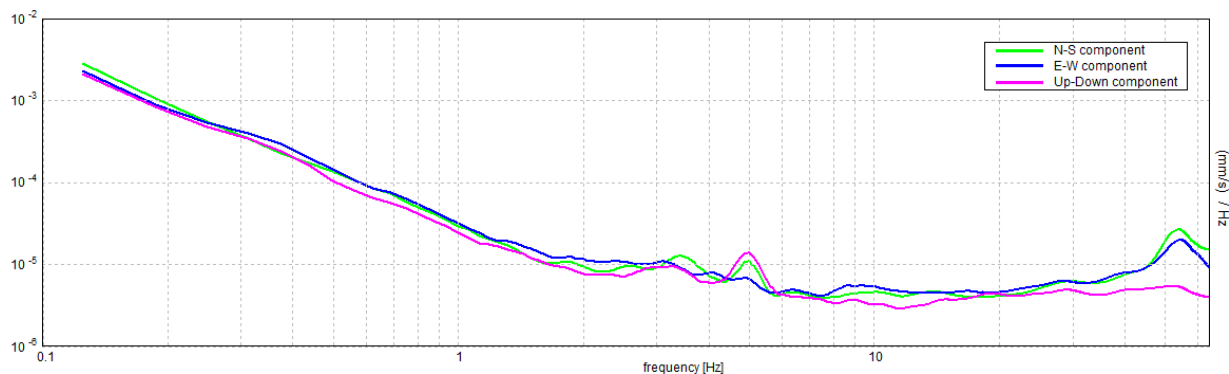
H/V TIME HISTORY



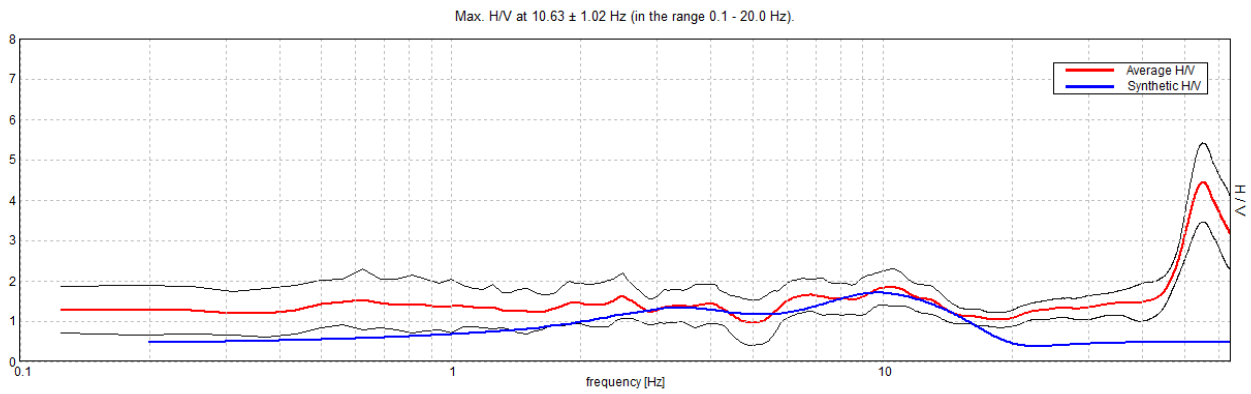

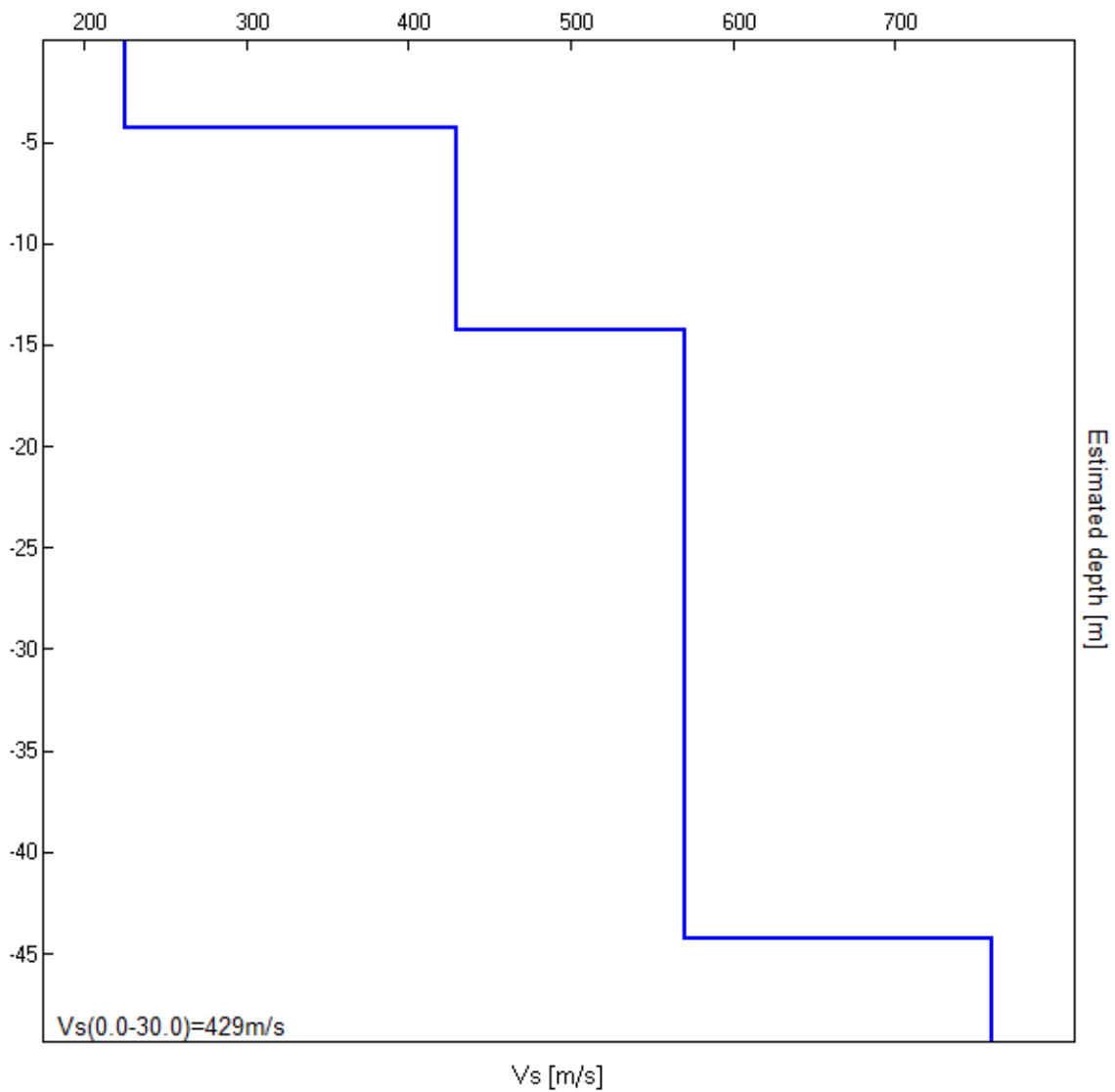

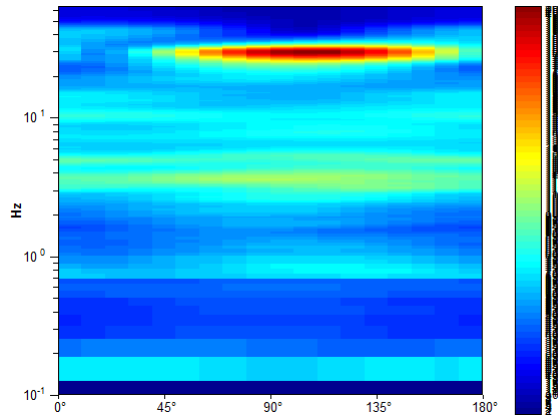

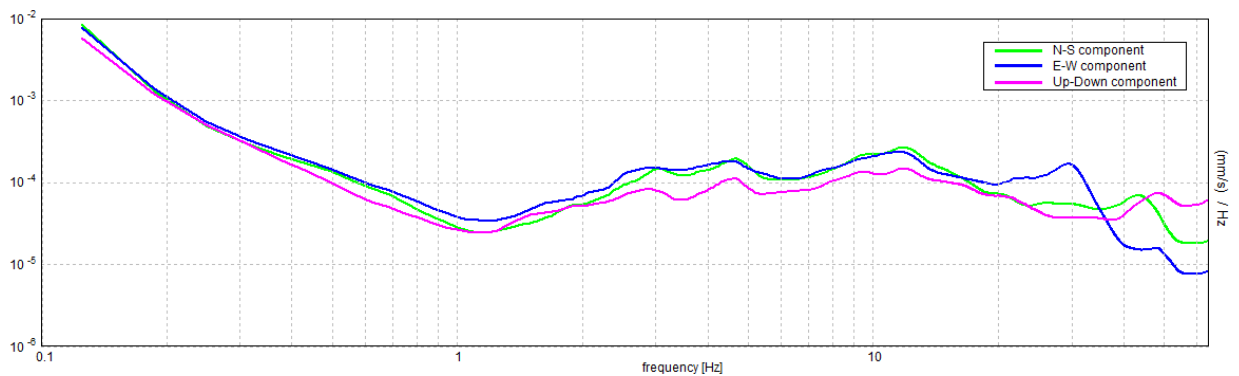
H/V TIME HISTORY

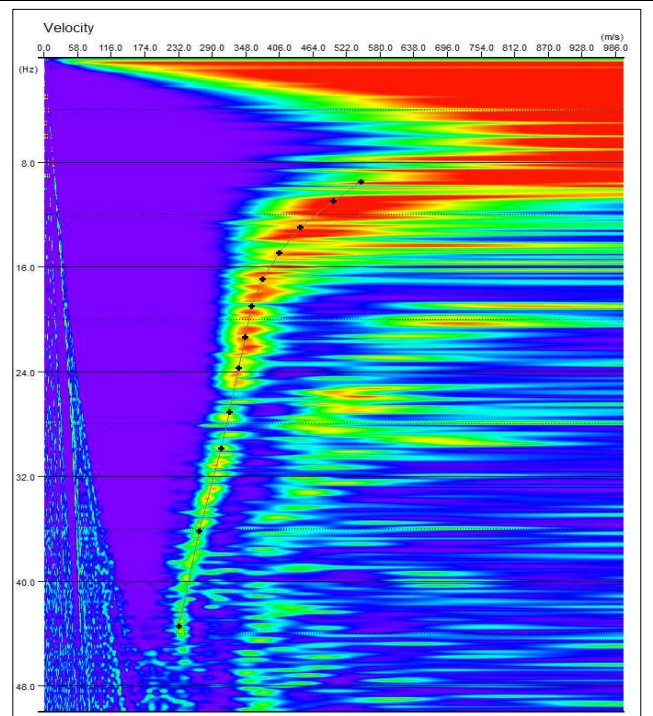

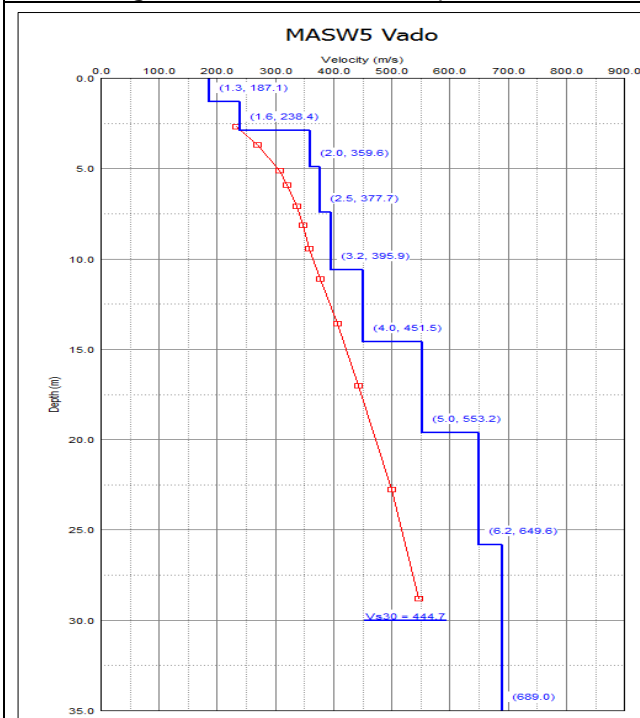

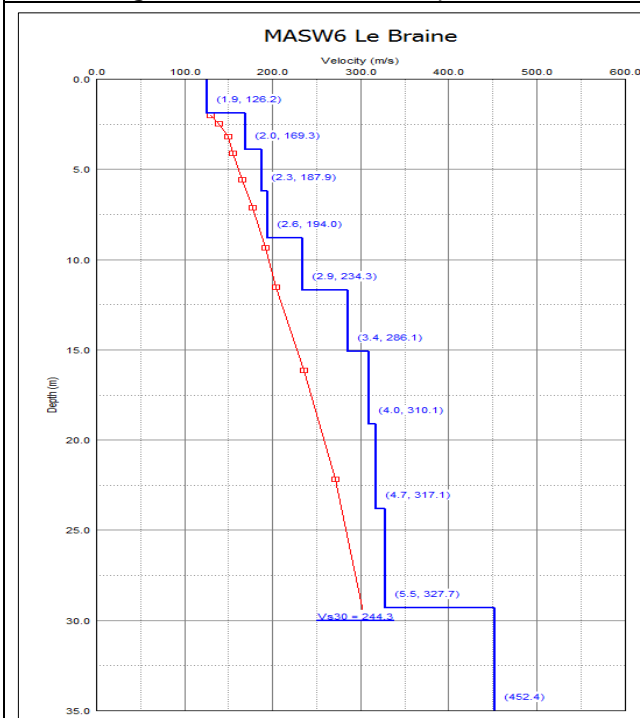

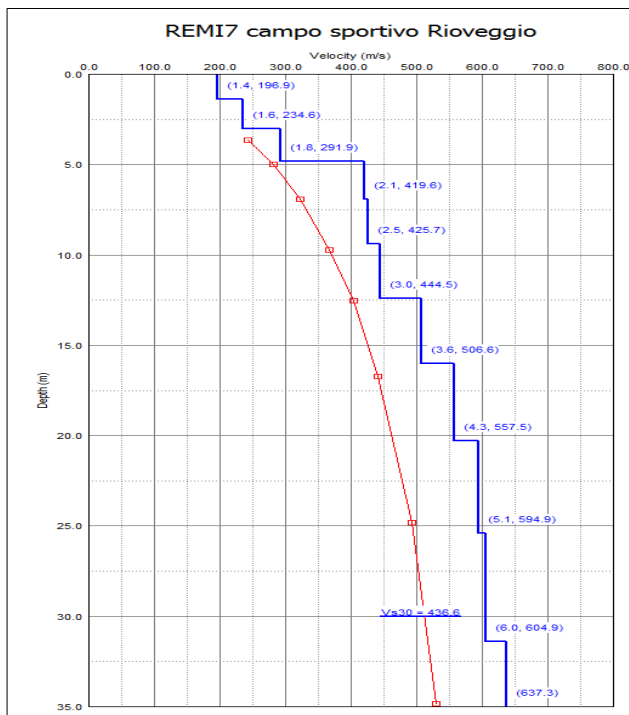

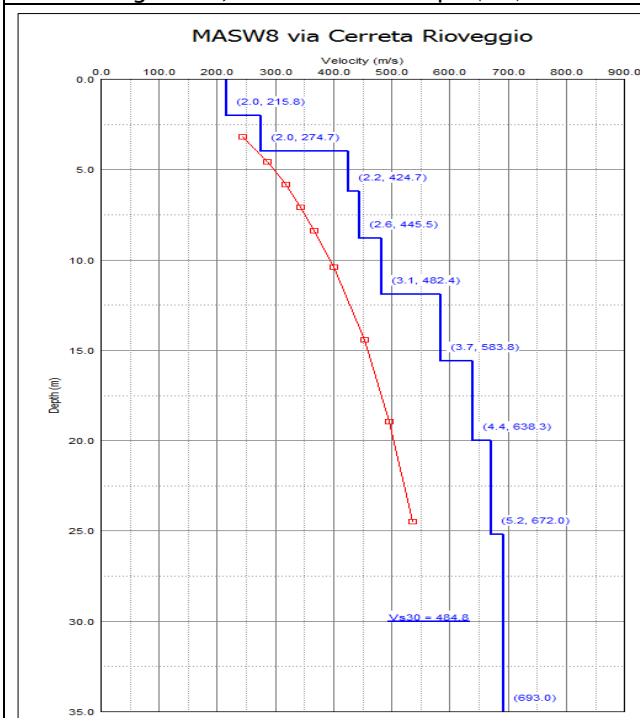
